

Procedures in case of suspected infection of an employee or student

1. If a participant (student, teacher) shows disturbing symptoms suggesting infection with coronavirus, he should be immediately removed from classes, isolated in a separate room prepared for this, in which there are personal protective equipment and disinfectants, with a minimum distance of 2 m from other people. The person providing help should exercise extreme caution and monitor their health condition over the next 2 weeks.
2. If the state of health does not require the assistance of the State Medical Rescue, this person should go home by individual transport, stay there and call a doctor by phone for medical advice, or with a sanitary and epidemiological station (in Lublin 693 397 187, 605 194 800), infectious diseases ward, and in the event of a deterioration in health, call 999 or 112 and inform that he may be infected with the coronavirus.
3. In the event of a person's health deteriorating, an ambulance should be called in order to be transported to the nearest infectious disease ward, and the Poviats Sanitary and Epidemiological Station should be immediately informed of the situation, which will conduct an initial epidemiological interview.
4. In the event of the above situation, classes in a given room/doctor's office should be suspended on that day and the area in which the person was moving should be thoroughly cleaned in accordance with the applicable procedures and the touch surfaces (handles, handrails, handles) should be disinfected with care. caution. Regarding the classroom/consulting room, this obligation is on the part of the unit, in the case of general parts (corridor, toilets, etc., on the side of the person responsible for cleaning the building).
5. In the "Record of participation in classes" it should be checked whether all Students/Employees who had contact with a person with disturbing symptoms were given.
6. One should follow the recommendations of the state poviats sanitary inspector in determining whether additional procedures should be implemented, taking into account the existing case.
7. A person with disturbing symptoms should not come to work/classes and is obliged to inform the Dean of the Faculty about their health condition and possible epidemiological risk.
8. It is recommended to follow the information of the Chief Sanitary Inspector (www.gis.gov.pl) and the Minister of Health (www.gov.pl/web/koronawirus), as well as the applicable legal regulations.

Hierarchy of actions taken:

1. The person conducting the classes informs the head of the teaching unit.
2. The head of the unit decides what to do (removal from classes, referral to a separate room, making a phone call regarding the telecounsel: 800 190 590, 693 397 187, 605 194 800, calling an ambulance if necessary).
3. The head informs the Dean of the Faculty about the situation and actions taken.
