

ORDER NO. 74
of the Rector of the University of Life Sciences in Lublin
dated 8 July 2026
regarding the fees payable for stays in the student halls of
residence of the University of Life Sciences in Lublin
in the 2026/2027 academic year

Pursuant to § 46 section 1 point 2 of the Statute of the University of Life Sciences in Lublin and § 9 section 1 of the Regulations for Student Halls of Residence of the University of Life Sciences in Lublin:

§ 1

The fees payable for accommodation in the student halls of residence of the University of Life Sciences in Lublin in the 2026/2027 academic year are established as follows:

- 1) for students and doctoral students of the University of Life Sciences in Lublin – Table 1 attached to the Order;
- 2) for employees of the University of Life Sciences in Lublin as well as students and doctoral students of higher education institutions other than the University of Life Sciences in Lublin – Table 2 attached to the Order;
- 3) for persons who are not students, doctoral students, or employees of the University of Life Sciences in Lublin, nor students of higher education institutions in Lublin – Table 3 attached to the Order.

§ 2

The setting of fees other than those resulting from the tables referred to in § 1 may take place solely upon the decision of the Rector and exclusively in the event of an extraordinary situation.

§ 3

1. No additional fees shall be charged for a person staying in a student hall of residence together with a child aged up to 3 years, for a period not exceeding 2 weeks during the academic year.
2. A person staying in the student dormitory with a child under the age of 3 for a period of at least 2 weeks during the academic year shall pay an additional fee of PLN 100 per month.
3. A guardian of a child over the age of 3 wishing to reside in the student dormitory—subject to the allocation of an additional space and the imposition of a fee equal to the rate for a place in a double room (as specified in Appendix No. 3)—may do so.

§ 4

1. Students and doctoral candidates of the University of Life Sciences in Lublin who leave their belongings in their currently occupied room during the summer break shall pay a monthly fee amounting to 30% of the monthly accommodation fee for that room, as determined in accordance with the applicable fee schedule.
2. The fee for each use of a washing machine available to residents of the University of Life Sciences in Lublin student dormitories is PLN 9 for 3 hours of use.

§ 5

1. Responsibility for the implementation of this Order is entrusted to the student dormitory administrators.
2. Supervision of the implementation of this Order is exercised by the Chancellor.

§ 6

1. As of 30 September 2026, Order No. 67 of the Rector of the University of Life Sciences in Lublin dated 14 July 2025 regarding the fees payable by persons residing in the student dormitories of the University of Life Sciences in Lublin during the 2025/2026 academic year shall cease to be in force.
2. This Order enters into force on 1 October 2026.
